PETITION FOR RECOVERY OF INDEBTEDNESS

Plaintiff, State of Oklahoma, *ex rel.* Oklahoma Tax Commission, alleges and states as follows:

1. That the Tax Warrants attached hereto as "Exhibit 1" through "Exhibit 6" and by this reference incorporated herein as if set out in full were filed in the Oklahoma & Cleveland County Clerks' Office against the real and personal property of Defendants.
2. That the total indebtedness as of the date of said tax warrants was \$32,061.48, such indebtedness arising as a result of the Defendants' failure to pay taxes for the following tax types and periods:





3. That a total indebtedness in the amount of \$32,061.48 as of November 4, 2025, remains unpaid.
4. That the Oklahoma Tax Commission, therefore, pursuant to 68 O.S. § 231(K), has all of the remedies and may take all of the proceedings thereon for the collection thereof which may be had or taken upon a judgment of the District Court.

WHEREFORE, Plaintiff prays that such garnishment action or actions be maintained, or any other actions as are needed against said Defendant in order to collect the full amount of indebtedness, together with interest, penalty, and fees as provided by 68 O.S. § 217, and for the costs of this action.
